**The closing date for the applications is 13 November 2022.** Delayed applications will not be considered. Invitations to attend the audition will be sent to selected candidates by e-mail by 15 November.

Piano accompaniment in concertos is mandatory. The application must include whether the applicant requests that the piano accompaniment be provided by the Slovak State Philharmonic Košice or by arranging his/her own accompanist; the application must also contain information about the selected concerto. The applicants may perform from sheet music.

The Slovak State Philharmonic Košice offers applicants:

- Salary based on Act no. 553/2003 Coll. on the remuneration of certain employees in the performance of work in the public interest and on the amendment of specific laws depending on the experience achieved;
- Six weeks of vacation;
- Food allowance;
- Other benefits according to the Collective Agreement.
