W. A. MOZART: Violin Concerto No. 3 in G Major (KV 216)

W. A. MOZART: Violin Concerto No. 4 in D Major (KV 218)

W. A. MOZART: Violin Concerto No. 5 in A Major (KV 219)

b) Orchestral excerpts – 2nd Violin:

STRAUSS: Don Juan, symphonic poem

MOZART: Symphony No. 39 E-flat major – 4th movement

2nd ROUND OF THE AUDITION:

SMETANA: The Bartered Bride – Overture

BRAHMS: Piano Concerto No. 1 – 3rd movement

THE DEADLINE FOR APPLICATIONS IS 9th JUNE 2025. Invitations to the audition will be sent to selected candidates by email no later than 12th June 2025.

Piano accompaniment in concertos is mandatory. The application must indicate whether the applicant requests the piano accompaniment to be provided by the Slovak State Philharmonic Košice or if they will arrange their own accompanist. **In case the applicant requests an accompanist from the Slovak State Philharmonic Košice, they should also send information about the selected concerto along with their application.**

Applicants may perform from sheet music.

Slovak State Philharmonic Košice offers the following:

- Salary based on Act no. 553/2003 Coll. on the remuneration of certain employees in the performance of work in the public interest and on the amendment of specific laws, depending on the experience achieved.
- Six weeks of vacation.
- Food allowance.
