The application must indicate whether the applicant requests the piano accompaniment to be provided by the Slovak State Philharmonic Košice or if they will arrange their own accompanist. In case the applicant requests an accompanist from the Slovak State Philharmonic Košice, they should also send information about the selected concerto along with their application.

Applicants may perform from sheet music.

Slovak State Philharmonic Košice offers the following:
