The closing date for the applications is 05 June 2022. Delayed applications will not be taken into consideration. **Invitations to attend the audition will be sent to selected candidates by e-mail by 10 June, 2022.**

Piano accompaniment in Mozart's and romantic concerto is mandatory. The application must include information on whether the applicant requests that the piano accompaniment be provided by the Slovak State Philharmonic Košice or by arranging his own accompanist. In case the applicant asks the accompanist of the Slovak State Philharmonic Košice, together with the application he/she will send information about the selected concerts and a scan/copy of the piano parts.

The whole programme may be performed from sheet music.

The Slovak State Philharmonic offers applicants:

- salary based on Act no. 553/2003 Coll. on the remuneration of certain employees in the performance of work in the public interest and on the amendment of certain laws depending on the experience achieved;
- 6 weeks of vacation;
- food allowance;
- other benefits according to the Collective Agreement.
